# Changes to the Scheme's MND selection process

As part of Trustee governance, the MND selection policy is regularly reviewed. Here are the highlights from the recent review, including how MND selection will work going forward.

When an MND vacancy arises, the Trustee Board will write to all members welcoming applications. If you're a deferred or pensioner Scheme member, you're eligible to apply by:

- completing an application form, including information about your background and why you think you'd make a good Trustee, and
- ensuring your application is supported by two other Scheme members – this is what makes you 'membernominated'.

Once all nominations are received, the Trustees will follow a selection process that may include interviews before appointing the successful applicant to the Board.
